Relevant Bankruptcy Court Docket Entries

Include the docket sheet from the Bankruptcy Court. You may order the docket sheet from the Bankruptcy Court, or, if you have a PACER account, you may print the docket sheet on line through PACER.

Complaint and Answer, or Other Equivalent Pleadings (i.e. Motion Filed)

Include a copy of the complaint and answer filed with the Bankruptcy Court, or, if the appeal does not arise from an adversary proceeding, include the Motion filed and any response to the Motion.

Note: *Bankruptcy Court's File Stamp.* Copies of all papers included in the appendix must show the bankruptcy court's mechanical or digital file stamp, or equivalent evidence of filing with the bankruptcy court. 10th Cir. BAP L.R. 8009-1(b)(6).

Any Pretrial Order

If the appeal involves an adversary proceeding in which the court entered a pretrial order, include the order in the appendix.

Note: *Bankruptcy Court's File Stamp.* Copies of all papers included in the appendix must show the bankruptcy court's mechanical or digital file stamp, or equivalent evidence of filing with the bankruptcy court. 10th Cir. BAP L.R. 8009-1(b)(6).

Transcript or Relevant Portions of Transcript

The appendix must contain all transcripts, or portions of transcripts, necessary for the court's review. If a party seeks to overturn a finding of fact, the entire transcript should be included.

The Judgment or Order from Which the Appeal Is Taken

Include a copy of the Bankruptcy Court's judgment or order being appealed.

Note: Bankruptcy Court's File Stamp. Copies of all papers included in the appendix must show the bankruptcy court's mechanical or digital file stamp, or equivalent evidence of filing with the bankruptcy court. 10th Cir. BAP L.R. 8009-1(b)(6).

The Bankruptcy Court's Opinion, Findings of Fact, or Conclusions of Law

If the Bankruptcy Court entered a written opinion, findings of fact, or conclusions of law in support of the order or judgment being appealed, include a copy.

If the Bankruptcy Court's decision is published, include the citation to the opinion.

If the Bankruptcy Court delivered its findings of fact or conclusions of law orally, include a transcript of the ruling.

Note: *Bankruptcy Court's File Stamp.* Copies of all papers included in the appendix must show the bankruptcy court's mechanical or digital file stamp, or equivalent evidence of filing with the bankruptcy court. 10th Cir. BAP L.R. 8009-1(b)(6).

Any Other Orders Relevant to the Appeal

If there are any other Bankruptcy Court orders that are relevant to the appeal, include them.

Note: *Bankruptcy Court's File Stamp.* Copies of all papers included in the appendix must show the bankruptcy court's mechanical or digital file stamp, or equivalent evidence of filing with the bankruptcy court. 10th Cir. BAP L.R. 8009-1(b)(6).

Any Motion and Response on Which the Bankruptcy Court Ruled

If the bankruptcy court ruled on a motion that is relevant to the appeal, include the motion and response.

Note: *Bankruptcy Court's File Stamp.* Copies of all papers included in the appendix must show the bankruptcy court's mechanical or digital file stamp, or equivalent evidence of filing with the bankruptcy court. 10th Cir. BAP L.R. 8009-1(b)(6).

Notice of Appeal

The appendix must contain a copy of the notice of appeal filed with the Bankruptcy Court.

Note: *Bankruptcy Court's File Stamp.* Copies of all papers included in the appendix must show the bankruptcy court's mechanical or digital file stamp, or equivalent evidence of filing with the bankruptcy court. 10th Cir. BAP L.R. 8009-1(b)(6).
